ANNUAL NOTICE OF MUNITIONS LIST ITEMS

Unless otherwise noted, sales, orders or quotes may include Munitions List Items (MLI) or Commerce Controlled List Items (CCLI). ANNUAL END USE / END USER DECLARATION

I (We) acknowledge that U.S. law prohibits the sale, transfer, export, or re-export or other participation in any export transaction involving products with individuals or companies listed in the U.S. Commerce Department's Table of Denial Orders, the U.S. Department of State's list of individuals debarred from receiving Munitions List Items.

4. I (We) will abide by all applicable U.S. export control laws and regulations for any products purchased from East Air Corporation and will obtain any licenses or prior approvals required by the U.S. Government prior to export or re-export of products, software or technology.

5. I (We) agree that the export control requirements in No. 1-4 above shall survive the completion, early termination, cancellation or expiration of the applicable purchase order, agreement or contract.
